### ANTI-RAGGING CELL

As per the order of the Supreme Court of India and subsequent Notification from the University Grants Commission (UGC), ragging constitutes one or more of any intentions by any student or group of students on:

1. Any act of Indiscipline, Teasing or Handling with Rudeness.
2. Any act that Prevents, Disrupts the Regular Academic Activity.
3. Any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
4. Any Act of Financial Extortion or Forceful Expenditure.
5. Any Act of Physical Abuse causing Assault, Harm or danger to Health.
6. Any Act of abuse by spoken words, emails, SMS or public insult etc.
7. Any Act of injury or infringement of the fundamental right to human dignity.
8. Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
9. Any unlawful assembly or conspiracy to ragging.

### Punishment to those found guilty

Any student or group of students found guilty of ragging on the campus or even outside the campus shall be liable to one or more of the following punishments

- Debarring from appearing in any sessional test / University Examination
- Suspension from attending classes and academic privileges
- Withdrawing scholarships and other benefits
- Suspension from the college for a period of one month

### Objectives of Anti Ragging Committee

Anti-Ragging Committee will be the Supervisory and Advisory Committee in preserving a Culture of a Ragging Free Environment on the college Campus. The Anti-Ragging Squad- office bearers will work under the Supervision of Anti Ragging Committee and engage in the works of checking places like the Hostel, Bus, Canteen, Classrooms and other places of student congregation. Anti-Ragging Committee will be involved in designing strategies and action plans for curbing the Menace of Ragging in the college by adopting an array of activities.

### Responsibilities of Anti-Ragging Squad

Anti-Ragging Squad will be working under the Monitoring of Anti-Ragging Committee and will seek advice from the Anti-Ragging Committee. The functions of the Anti-Ragging Squad will be to keep a vigil and stop the incidences of Ragging, if any, happening/reported in the places of Student aggregation including, Classrooms, Canteen, Bus, Ground, Hostel etc. The Squad will also educate the students at large by adopting various means about the menace of Ragging and related Punishments there. A gamut of positive reinforcement activities is adopted by Anti-Ragging Squad for orienting students and moulding their personalities for a better cause. They shall work in Consonance and Guidance of Anti Ragging Committee.

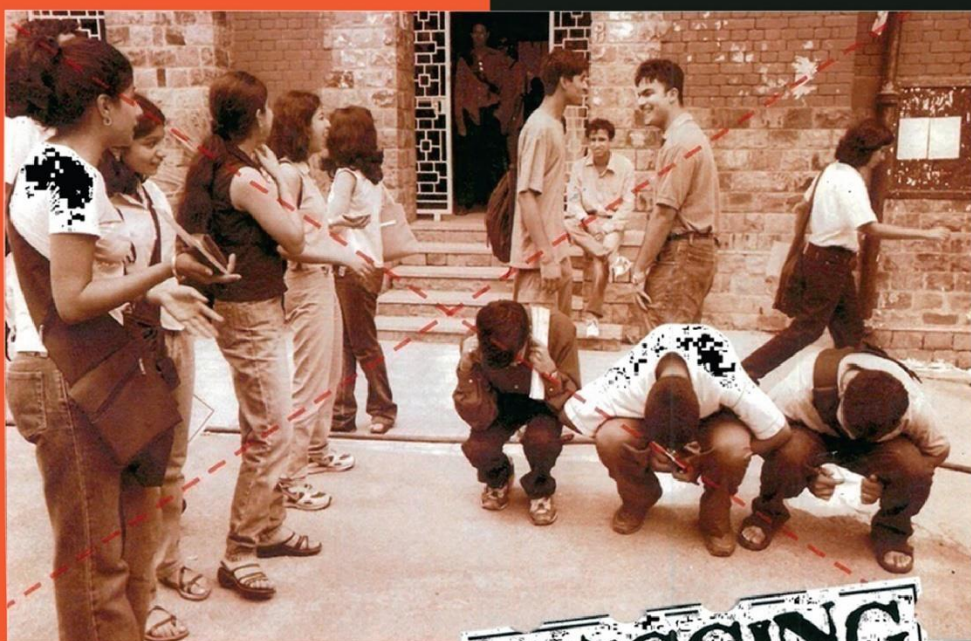
**Powers & functions of the Anti-Ragging Committee:**

1. To uphold and comply with the direction of the Hon'ble Supreme Court and be vigilant on any acts amounting to ragging.
2. To inform all students and prevalent directives of action that can be taken against those indulging in ragging.
3. To consider complaints received from the students and conduct enquiry and submit the report to the Principal along with the punishment recommended for the offenders.
4. Form an Anti-ragging squad to make surprise visits and take effective steps to prevent ragging.
5. Oversee the procedure of obtaining an undertaking from the students by the provision.
6. Conduct a workshop against the ragging menace and orient the students.
7. To provide students with the information about the contact address and telephone no of the person identified to receive complaints/ distress calls.
8. To offer the service of counselling and create awareness of ragging inside the Campus/ Hostel.
9. To take all necessary measures for preventing ragging inside the Campus/Hostel.
10. The committee shall monitor the functioning of the anti-ragging squad.

**Powers & functions of Anti Ragging Squad:**

1. Conduct anonymous random surveys/ raids and ensure that students do not indulge in the act of ragging in the campus/ hostel and take adequate measures to prevent it.
2. The squad shall report to the Anti-Ragging committee any incidents of ragging which come to their notice.
3. The Chairman shall report to the Anti-ragging committee the details of the visit.
4. The squad shall work under the overall guidance of the Anti-Ragging committee.

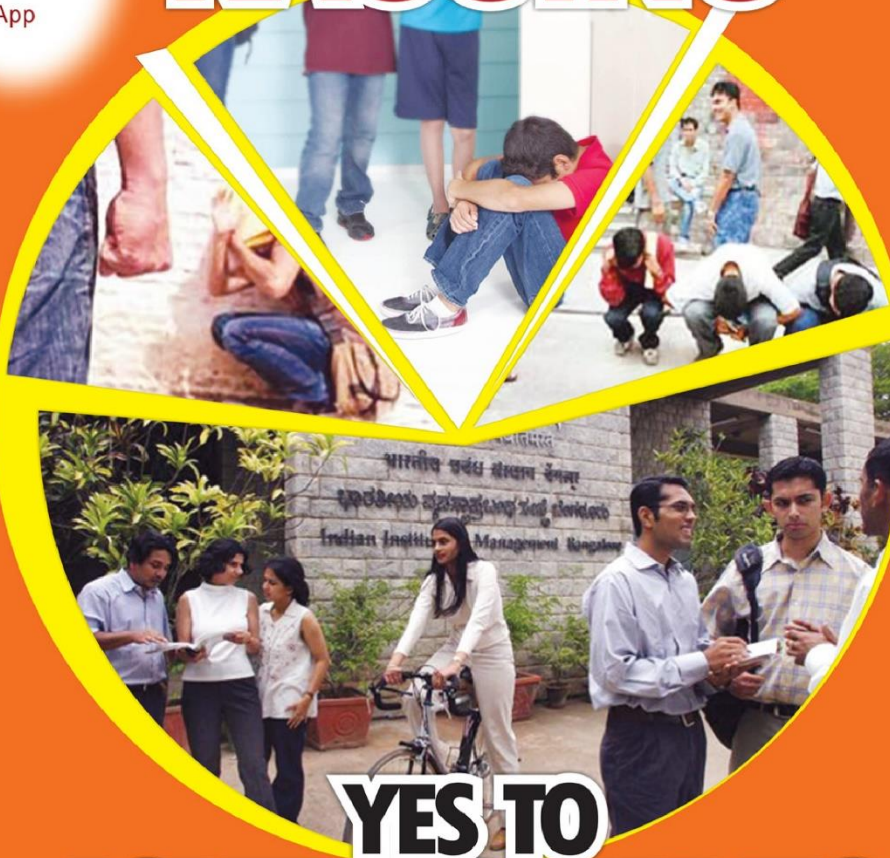

## What is Ragging? Any Act Resulting in:

- Mental/physical/sexual Abuse
- Verbal Abuse
- Indecent Behaviour
- Criminal Intimidation/wrongful Restraint
- Undermining Human Dignity
- Financial Exploitation/extortion
- Use Of Force

### A STUDENT INDULGING IN RAGGING CAN BE:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.
- **Collective punishment** : when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.
